

# DASSAULT SYSTEMES LICENSED PROGRAMS TERMS (LPT) FOR 3DEXPERIENCE R2021x ADDITIONAL TERMS #1

Due to new available [Licensed Programs](#), these additional terms #1 supplement the Licensed Programs Terms for 3DEXPERIENCE R2021x and are an integral part of such Licensed Programs Terms. Except as expressly supplemented by these additional terms #1, all terms and conditions of the Licensed Programs Terms for 3DEXPERIENCE R2021x shall remain in full force and effect.

The Licensed Programs Terms for 3DEXPERIENCE R2021x together with these additional terms #1 ("LPT") and the terms incorporated herein by reference (including terms referenced on a website) are an integral part of the license agreement between DS and Licensee ("Agreement"), which refers to this LPT. In the event of a discrepancy, inconsistency or contradiction between this LPT and the other terms of the Agreement, the provisions of this LPT shall prevail, but only with respect to the Licensed Programs to which this LPT applies. Licensee acknowledges that it has full knowledge of all the terms of this LPT and those incorporated herein by reference.

## 2. LICENSING SCHEMES AND GEOGRAPHIC SCOPE

### 2.2 SPECIFIC PROVISIONS FOR CERTAIN LICENSED PROGRAMS

#### **SIMULIA - 3DEXPERIENCE Simulation business category**

The following provisions supersede those of the corresponding section of the Licensed Programs Terms for 3DEXPERIENCE R2021x:

##### ***Embedded Compute capability***

*For Licensed Programs which comprise client applications (graphical user interface) and compute capabilities, client applications and compute capabilities shall not be operated simultaneously by more than one (1) authorized [User](#) and/or [Extended Enterprise User](#), as applicable.*

##### ***Token Based Licensed Programs***

*[Token Based](#) Licensed Programs from the 3DEXPERIENCE Simulation business category may be accessed and executed by Users whose usual workplace is limited to one (1) Licensee facility (location) where the Licensed Programs are deployed.*

*Token Based Licensed Programs from the 3DEXPERIENCE Simulation business category, as specified in the [Product Portfolio](#), provide a right to a maximum number of independent or concurrent simulation jobs. Simulation jobs include solver execution and may include other operations as specified in the [Documentation](#) ("Simulation Jobs"). The maximum number of Simulation Jobs at any time is determined by: (i) the number of tokens included in the granted Licensed Programs and (ii) the number of tokens required for each Simulation Job as specified in the Product Portfolio.*

##### ***Credit Based Licensed Programs***

*[Credit Based](#) Licensed Programs from the 3DEXPERIENCE Simulation business category, as specified in the Product Portfolio, provide a right to a maximum number of Simulation Jobs and/or access to additional services to execute those simulations over the term of the Licensed Program. The number of credits required to execute a Simulation Job and, if applicable, correlative additional services, is determined in the Product Portfolio.*
