In the event of a discrepancy, inconsistency or contradiction between this LPT and the other terms of the Agreement, the provisions of this LPT shall prevail, but only with respect to the Licensed Programs to which this LPT applies. Licensee acknowledges that it has full knowledge of all the terms of this LPT and those incorporated herein by reference.

## 5. ADDITIONAL DEFINITIONS

Affiliate's User means any (a) Affiliate's employee, or (b) employee of Affiliate's consultant(s) or subcontractor(s) (i) who accesses a Licensed Program, (ii) who works for the exclusive internal needs of Affiliate and (iii) whose usual workplace is located within Affiliate's premises. Subject to the terms and conditions of this Agreement, including without limitation, export-related obligations, Affiliate's employee may also work according to Teleworking conditions.

Machine means a device on which a Licensed Program is executed and which is either (1) (i) (a) belonging to Licensee (or under its sole control or supervision) or to an Affiliate (or under its sole control or supervision) and (b) located on Licensee's premises or Affiliate's premises (provided when applicable that Users, Affiliate's Users, Extended Enterprise Users and Affiliate's Extended Enterprise Users, as applicable, may occasionally use laptop computers outside Licensee's premises or Affiliate's premises) or (ii) authorized by Licensee or an Affiliate according to its own information technology charter or equivalent whereby third party devices (such as Users or Affiliate's Users own devices) are specifically authorized, or (2) operated by a third party service provider as specifically authorized in the Agreement solely for and on behalf of Licensee or Affiliate, as applicable.

**Teleworking** means any program authorized by and for the benefit of Licensee or an Affiliate to enable its employees to work outside its own premises, using information and communication technology. Any use of Licensed Programs while Teleworking is authorized if all of the following conditions are at all times met: (a) Licensee's or Affiliate's employees do so on Machine(s) connected to Licensee's or Affiliate's network (e.g. via Virtual Private Network), (b) Licensee or Affiliate is able to provide access to such Machine(s) during a compliance verification according to the Agreement, and (c) Licensee's or Affiliate's employees use the Licensed Programs for Licensee's or Affiliate's exclusive internal needs.
