

DASSAULT SYSTEMES OFFERING SPECIFIC TERMS (OST) FOR 3DEXPERIENCE R2020x LICENSED PROGRAMS ADDITIONAL TERMS #2

Due to new available Licensed Programs, these additional terms #2, which supplement the Offering Specific Terms for 3DEXPERIENCE R2020x Licensed Programs and the additional terms #1, are an integral part of such Offering Specific Terms. Except as expressly supplemented by these additional terms #2, all terms and conditions of the Offering Specific Terms for 3DEXPERIENCE R2020x Licensed Programs and the additional terms #1, shall remain in full force and effect.

The Offering Specific Terms for 3DEXPERIENCE R2020x Licensed Programs, the additional terms #1 together with these additional terms #2 (OST) and the terms incorporated herein by reference (including terms referenced on a website) are an integral part of the license and online services agreement between DS and Customer ("Agreement"), which refers to this OST. In the event of a discrepancy, inconsistency or contradiction between this OST and the other terms of the Agreement, the provisions of this OST shall prevail, but only with respect to the Licensed Programs to which this OST applies. Customer acknowledges that it has full knowledge of all the terms of this OST and those incorporated herein by reference.

2. LICENSING SCHEMES AND GEOGRAPHIC SCOPE

2.1 GENERAL RULES

The following licensing scheme supplements those of the corresponding section of the Offering Specific Terms for 3DEXPERIENCE R2020x Licensed Programs:

2.2 SPECIFIC PROVISIONS FOR CERTAIN DS OFFERINGS

CATIA - 3DEXPERIENCE Design/Engineering business category

The following provisions supplement those of the corresponding section of (i) the Offering Specific Terms for 3DEXPERIENCE R2020x Licensed Programs and (ii) the additional terms #1:

For each Multi-Discipline Drafter Credit Small Pack (6TB-ACP-S) Credit Based Licensed Program, Customer is granted the right to generate four thousand (4000) views, unless defined differently in the Documentation. A view has to be understood as view that can be generated for drawing in a sheet through Piping & HVAC Automated Drafter (6NB-ABP, 6CB-ABP-C) Licensed Program. The number of views is specified and enabled on an annual basis. For terms different from one (1) year, the number of views is pro-rated. For terms of one (1) year or less, any unused views expire at the end of the term of the Licensed Program. For terms longer than one (1) year, the views are enabled every year on an annual basis until the end of the term of the Licensed Program; any unused views expire twelve (12) months after they are enabled.

5. DEFINITIONS

5.3 LICENSING SCHEME DEFINITIONS

The following definition supplements those of the section "Definitions" of the Agreement.

Credit Based. *Use of a DS Offering granted in Credit Based mode provides a right to consume a determined number of credits for the access duration to the DS Offering. Credits are for a one-time use (consumable and not reusable) and not refundable. Unused credits expire at the end of the validity period. The quantity of credits required for a given use of the DS Offering is determined in the Product Portfolio and/or in the Documentation, and may be changed in the event of modifications to such DS Offering. Pool of credit(s) of same type can be accessed simultaneously by one or several authorized Users and/or Extended Enterprise Users and/or Machines, as applicable, within the limit of the number of remaining available credits.*

Credits of given type(s) may be required to enable use of other DS Offerings.
