# DASSAULT SYSTEMES OFFERING SPECIFIC TERMS (OST) FOR 3DEXPERIENCE R2022x ONLINE SERVICES ADDITIONAL TERMS #3

Due to new available Online Services, these additional terms #3, which supplement the Offering Specific Terms for **3D**EXPERIENCE R2022x Online Services, the additional terms #1 and the additional terms #2, are an integral part of such Offering Specific Terms. Except as expressly supplemented by these additional terms #3, all terms and conditions of the Offering Specific Terms for **3D**EXPERIENCE R2022x Online Services, the additional terms #1 and the additional terms #2 shall remain in full force and effect.

The Offering Specific Terms for **3D**EXPERIENCE R2022x Online Services, the additional terms #1, the additional terms #2 together with these additional terms #3 (OST) and the terms incorporated herein by reference (including terms referenced on a website) are an integral part of the license and online services agreement between DS and Customer ("Agreement"), which refers to this OST. #### **Business Process Service Task**

For terms longer than one (1) year, business process service tasks are issued per year and unused business process service tasks expire at the end of the given year period; for any incomplete year period, the number of issued business process service tasks is pro-rated and unused business process service tasks expire at the end of the given service tasks expire at the end of the given period.

#### **Biosphere Material Compute Units**

For each Computational Structural Biologist (6NB-BCB-OC), Computational Chemist (6NB-BCH-OC) and Materials Modeler (6NB-BMA-OC) Online Service, Customer is delivered five hundred thousand (500,000) biosphere material compute units, unless defined differently in the Documentation. For each Generative Therapeutics Design for one project (6MB-GTDP1-OC) Online Service, Customer is delivered three hundred thousand (300,000) biosphere material compute units, unless defined differently in the Documentation. Consumption rules of biosphere material compute units are specified in the Documentation.

For one (1) Platform, biosphere material compute units are shared among all the authorized Users (and/or Extended Enterprise Users, as applicable). Such units belonging to one (1) Platform cannot be transferred to another Platform.

The number of biosphere material compute units is specified on a yearly basis. For terms of one (1) year or less, all biosphere material compute units are issued at the beginning of the term and unused biosphere material compute units expire at the end of the term. For terms longer than one (1) year, biosphere material compute units are issued per year and unused biosphere material compute units expire at the end of the given year period; for any incomplete year period, the number of issued biosphere material compute units is pro-rated and unused biosphere material compute units expire at the end of the given incomplete year period.

## CATIA - 3DEXPERIENCE Design/Engineering business category

#### **Design Exploration**

The following provisions supersede those of the corresponding section of the Offering Specific Terms for **3D**EXPERIENCE R2022x Online Services and the additional terms #1:

For each Design Automation Engineer (6NB-AEN-OC), Concept Structure Engineer (6NB-CSE-OC, 6NB-CSE-OP) and Stiffened Structures Concept Design Engineer (6NB-SSCEN-OC) Online Service, Users (and Extended Enterprise Users, as applicable) are granted the right to automatically generate (in the background, in addition to the interactive session) a given number of iterations in context of design explorations. Each iteration corresponds to a given computation of a given design alternative. It namely applies when using « Design Improvement Study » in the application « Parametric Design Study ».

For each Design Automation Engineer (6NB-AEN-OC), Concept Structure Engineer (6NB-CSE-OC, 6NB-CSE-OP) and Stiffened Structures Concept Design Engineer (6NB-SSCEN-OC) Online Service, Users (and Extended Enterprise Users, as applicable) are granted the right to generate shapes with a cumulative number of features, as defined in the Documentation. A feature has to be understood as a sub-component of a shape.

The number of features is specified on a yearly basis. For terms of one (1) year or less, all features are issued at the beginning of the term and unused features expire at the end of the term. For terms longer than one (1) year, features are issued per year and unused features expire at the end of the given year period; for any incomplete year period, the number of issued features is pro-rated and unused features expire at the end of the given incomplete year period.

The number of views is specified on a yearly basis. For terms of one (1) year or less, all views are issued at the beginning of the term and unused views expire at the end of the term. For terms longer than one (1) year, views are issued per year and unused views expire at the end of the given year period; for any incomplete year period, the number of issued views is pro-rated and unused views expire at the end of the given incomplete year period.
