

SPECIFIC SERVICES TERMS FOR

V6 Online Companion V6R2013x

Terms that are initially capitalized are defined in the Online Services Agreement (OSA) between DS and Customer ("Agreement"), which refers to this Specific Services Terms (SST).

This SST and the terms incorporated herein by reference (including terms referenced on a website), are an integral part of the Agreement, which refers to this SST. In the event of a discrepancy, inconsistency or contradiction between this SST and the other terms of the Agreement, the provisions of this SST shall prevail, but only with respect to the Online Service(s) to which this SST applies. Customer acknowledges that it has full knowledge of all these terms and those incorporated herein by reference.

AVAILABLE PRICING STRUCTURES

Online Service(s) to which this SST applies may be ordered according to one of the following pricing structures:

- YLC
 - YLC is a yearly charge for access to the Online Service(s) for a period of one (1) year (subject to the conditions set forth in the Agreement).

Other pricing structures may be made available on a case by case basis.

ONLINE SERVICE GRANT SCOPE

The Online Services to which this SST applies are provided pursuant to the Agreement, with the following scope:

- An Online Services authorized user ("**Named-User**") is a single individual who is authorized to use the Online Services. A named-user must be either an employee or a subcontractor of the Customer and his/her access to the Online Services must be for the exclusive internal use of the Customer.
- All Online Services Named-Users must create an account on Companion Learning Space (http://companion.3ds.com), a platform which enables the Customer to train its Named-Users on how to use the Dassault Systèmes products. Each Named-User can launch all of the courses included in the Online Services as specified in the related Ordering Documents.
- The Customer and the Named-Users are not authorized to download the courses on their computers or on any of their hardware devices.
- The Customer will have access to a private space, called the "Customer domain", created on Companion Learning Space and specifying the number of courses purchased by the Customer. Any additional course purchased by the Customer will be included within this "Customer domain". Each Named-User can access the "Customer domain" or any of its sub-domains as specified in the related Ordering Documents.
- The Customer will have at least one specific user with dedicated privileges to administrate the "Customer domain" ("Administrator"). The Administrator will be responsible for creating the Named-Users accounts and sub-domains, and allocating the courses to the Named-Users in compliance with the terms of the Agreement and the related Ordering Documents. The Administrator is not authorized to access or use the Online Services for any other purpose than the administration of the Online Services.
- Each Named-User must be assigned for a minimum duration of thirty (30) days, even if the Named-User access to the Online Services is removed during this period. The total number of reassignments cannot exceed ten (10) % per year of the total number of Online Services purchased during the contract period.
- Online Services are purchased at the DS country price applicable to the Customer, wherever the Named-User is located.
