

SPECIFIC SERVICES TERMS FOR n!Volve V6R2013

Terms that are initially capitalized are defined in the Online Services Agreement (OSA) between Dassault Systèmes and Customer ("Agreement"), which refers to this Specific Services Terms (SST).

This SST and the terms incorporated herein by reference (including terms referenced on a website) are an integral part of the Agreement, which refers to this SST. In the event of a discrepancy, inconsistency or contradiction between this SST and the other terms of the Agreement, the provisions of this SST shall prevail, but only with respect to the Online Service(s) to which this SST applies. Customer acknowledges that it has full knowledge of all these terms and those incorporated herein by reference.

AVAILABLE PRICING STRUCTURES

Online Service(s) to which this SST applies may be ordered according to one of the following pricing structures:

YLC

YLC is a yearly charge for access to the Online Service(s) for a period of one (1) year (subject to the conditions set forth in the Agreement).

QRC

QRC is a quarterly charge for access to the Online Service(s) for a period of (3) months (subject to the conditions set forth in the Agreement).

Other pricing structures may be made available on a case by case basis.

ONLINE SERVICES GRANT SCOPE

The Online Services to which this SST applies are provided pursuant to the Agreement, with the following scope:

- Online Services authorize use of a single or multiple online environments ("Online Environments") which is created for and administered by the Customer. An Online Environment is an environment composed of a set of services that can share data, share resources (disk space capacity, CPU,...) and share a people&organisation (including the definition of the list of users).
- Online Services authorized user is a single individual authorized to use a given Online Environment ("Named-User"). Named-Users can be either the Customer's employees or a third party individual invited and authorized by the Customer. If an individual needs to access two Online Environments, it will be considered as two Named Users, even if they have the same login.
- Each Online Services Named User license must be assigned to a specific Named User for a minimum duration of one month (30 days), even if the user's access is removed during this period.
- All Online Services Named-Users must have a Dassault Systèmes Passport account and be registered on https://iam.3ds.com/service/social/.
- Online Services are provided for a maximum number of Named-Users for which the Customer has purchased rights to access to such Online Services.
- Online Services include a maximum disk storage capacity owned by the Customer equal to the sum of the
 disk space purchased for such Online Services. This disk space is split between the environments in the
 following manner: Named-User access for "n!Volve (OVT)" Online Services provides the right to 50GB of
 initial disk space. Such a disk space is added to the Customer disk storage capacity and is not attached
 specifically to a Named-User, it is attached to an Online Environment. The Customer may also access
 additional disk space by purchasing:
 - o "Online additional disk space +50GB" (OGB) provides 50GB of additional disk space.
- Online Services include the Dassault Systèmes Support Services level ADVANTAGE, as described in the
