BIOVIA Content team will review the submission for suitability to be listed in ACD or SCD, and report back to the supplier.

When submitting electronic data, please send a complete representation of your product data (i.e. the same data you provide in a printed catalog).

### File must be electronic submission

- BIOVIA RDF file
- Microsoft® Excel® spreadsheet
- Microsoft® Access® database
- Oracle® tables (as Oracle export file)
- Delimited ASCII text file

### File must include following:

- Catalog Number (SKU, if available)
- Chemical Name
- Availability of product
- Package Quantity, Package Unit, Price for each product

### Other data to include if available:

- Structure (sdf file format)
- Synonyms
- CAS Registry Number
- GHS data
- SDS url links to product website
- Purity
- Specification/Grade
- Hazard, Risk, and Safety data
- Shipping data

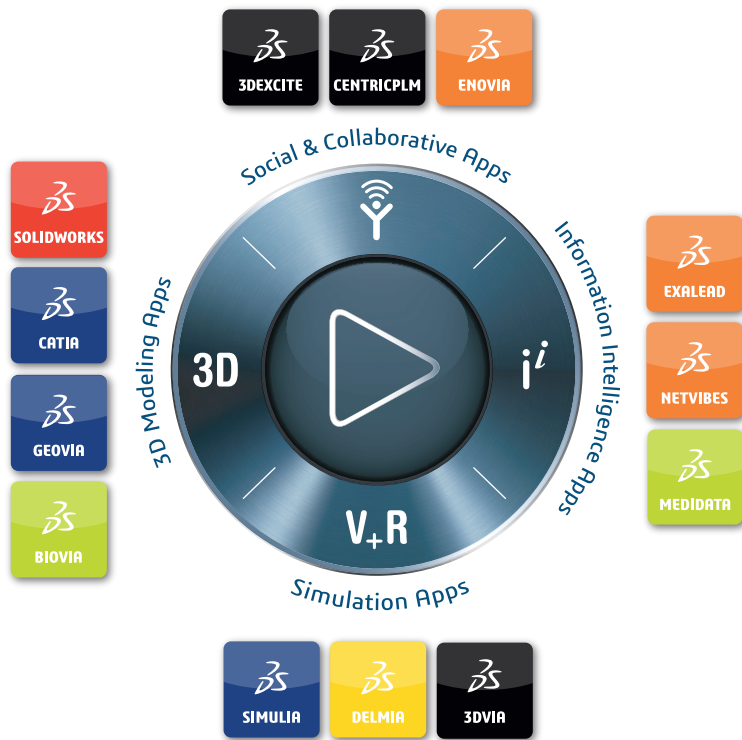

## TIPS FOR SUBMITTING SUPPLIER DATA:

1. Full product updates for each submission are preferred. If supplemental product updates are submitted, clearly identify as a supplemental update.
2. Catalog numbers must be persistent from one submission to the next. Package-specific catalog numbers (SKUs) are preferred. If catalog numbers are reassigned, this will result in a delay in updating catalog data.
3. All data fields should include a single data point, purity, or synonym, and primary name should be in separate data fields.
4. Quantity, Unit, Price should be in consistent format, with currency clearly identified, and parsed into separate data fields.
